OFFICE/SHOP OPERATING HOURS: 8.00am – 8.00pm CST

CHECK OUT TIME ON DAY OF DEPARTURE: 10.00am CST (Prompt please)

LAUNDRY: Washing and drying facilities are located in both facility blocks. Machines require \$4.00 token per wash, \$1.00 for the dryer. Tokens can be obtained at the office/shop. Ironing boards available in laundries.

CHILDREN: Parents and caregivers please supervise and control your children while using park facilities. **Bikes, skateboards, roller blades, skates or scooters are NOT permitted in or around facility blocks. NO BICYCLES OR SCOOTERS TO BE RIDDEN AFTER SUNSET.**

Conditions of Stay

1. I agree that the BHSBC Inc. or its representative shall be at liberty to cancel this licence upon giving **one hours' notice** which may be given at any time. **NO REFUNDS**
2. Name on booking of site/unit is responsible for those in their party and their guests to behave in an acceptable manner.
3. **ACCOMMODATION:** There is **NO SMOKING** permitted in our accommodation units. Please leave your dishes as you found them. To help with our maintenance please notify us of any breakages, spills or faulty equipment.
4. Dogs must be on leads and kept out of all buildings and off beach and restricted lawn area's at all times.
5. **Vehicles must not exceed walking pace (10km/h).** All roads in Caravan Park are primarily footpaths so please be careful of children at play. Violations could lead to your car being denied entry.
6. **Visitors cars** must be left outside the Caravan Park, in the parking area provided (for disabled or elderly permission must be sought from the caretaker for visitors car entry).
7. Unregistered motor vehicles are not to be ridden/driven in Caravan Park or on club Leases (BSHSB Inc equipment to be exempt from this ruling).
8. **No open fires permitted**, fire buckets **NOT** permitted on lawns except in designated areas, see caretaker.
9. All garbage must be **well wrapped** and place din receptacles provided. Waste water from caravans must be caught in receptacles and emptied into waste traps. Receptacles must not be allowed to overflow.
10. Removal or wilful damaging of trees and scrubs, and caravan amenities and fittings provided will be punished by law.
10. **No maintenance** work on cars or caravans permitted on site.
11. No loud music or noise, parties to cease at midnight.
12. No peddling, or soliciting, or commercial enterprise is allowed in the Reserve without first obtaining the consent of the management.
13. **FISH CLEANING:** Please clean all fish in the fish cleaning area and wrap waste and put in bin provided.
14. I agree that I shall occupy the site allotted to me, and use the parking facilities and amenities thereat, at my own risk in all things, and I absolve the proprietors from liability to any damage or loss, caused to me, the members of my party or my guests, or to any of my, or their goods, whilst a the said Club's Reserve and I indemnify, and agree, to keep the proprietors indemnified accordingly.
